

## **Rosthern Junior College (RJC) Custodian Agreement**

This document must be read and signed by the student and parents and/or legal guardians.

1. This Agreement will be in force when the following conditions are met:
  - i The Student resides in the RJC Residence (from September to June);
  - ii The Student has a valid Study Permit lawfully issued by the Government of Canada;
  - iii The Student is younger than 19 years old; and
  - iv This Agreement has not been terminated for any reason.
2. I/We agree that by signing this Agreement I am giving RJC permission to disclose information about the Student to the Student's parents/guardians, to Citizenship and Immigration Canada, other government agencies operating under statutory authority and, in the case of medical emergencies, doctors, nurses and other medical staff as may be appropriate and necessary.
3. I/We, while the Student is in Canada, agree that the Student will obey all national, provincial and municipal laws and will obey the rules and regulations of RJC.
4. I/We agree that the Student will live in the RJC Residence until the end of the school year. If the Student moves out from the RJC Residence this Custodian Agreement will be terminated and Citizenship and Immigration Canada will be notified.
5. I/We agree to appoint an alternate Custodian during the summer holidays if the Student is staying in Canada. I/We will inform RJC of all information, including contact information, of the alternate Custodian.
6. If the Student withdraws from RJC to attend another educational institute this Custodian Agreement will be immediately cancelled and Citizenship and Immigration Canada will be notified.
7. The Student shall only operate motorized vehicles while possessing a valid driver's license recognized as valid in the Province of Saskatchewan. I/We acknowledge and have given careful consideration to RJC's recommendation that the Student complete a driver safety training program in Saskatchewan.
8. I/We can terminate this agreement at anytime. I/We will take all legal responsibility for the Student upon termination. I/We understand that RJC will inform Citizenship and Immigration Canada about the termination of this Custodian Agreement.

9. Any termination of the Agreement will be made in writing and promptly delivered to the other party (s) of this agreement, either by certified express mail or by electronic mail.

I/We understand that the Student is expected to follow and adhere to all the terms stated. I/We also understand that if the Student does not, this Custodian Agreement may be terminated and RJC will notify Citizenship and Immigration Canada.
